4. Project/Program Description

The Florida National Guard was awarded a \$25 million appropriation in 2021 to construct a new facility in the City of Zephyrhills. The Guard selected a location just north of 6th Avenue and South Avenue and the Zephyrhills Municipal Airport. The proposed site does not currently have an improved access from 6th Avenue.

The project consists of purchasing the right-of-way, a .25 mile roadway to access the Guard site, stormwater, and extension of 1,300 +/- linear feet of a water main and sewer main to service the site from the 6th Avenue/South Avenue intersection. The industrial access road is a critically important roadway segment that will provide access to both the Guard and industrial development in the future.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The project consists of roadway improvements of about 1,300 LF of a new industrial access road to that will terminate at the proposed National Guard site. The work also includes purchase of the right-of-way, construction of drainage improvements, and about 1,300 LF of water and sewer mains.

b. What activities and services will be provided to meet the intended purpose of these funds?

The activities and services consist of purchase of right-of-way, design, permitting, and construction of the proposed roadway, water main, and sewer main for 1,300+/- feet north of 6th Avenue.

c. What direct services will be provided to citizens by the appropriation project?

Direct services provided to citizens by the project will be access to the National Guard site, access to future industrial land, and potential relocation of 6th Avenue to allow the airport to utilize the full length of runway 1-19.

d. Who is the target population served by this project? How many individuals are expected to be served?

At this time, the target population is the Florida National Guard with a minimum 300-400 guardsmen benefiting from the roadway and utility improvements. 350 acres of adjacent land to the proposed improvements is proposed to be developed as industrial.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The benefits of this project include improving the accessibility of the Guard site along with promoting growth, economic development, and job creation. The methodology for this project includes structural as well as non-structural components to provide a comprehensive project. This project will also have a public involvement component, continuing the town's efforts to interact with and inform the local residents on the project goals.
