;	The Town of Bascom sits in the northern part of Jackson County between the Town of Malone and the Town of Greenwood. The proposed project is to construct a power-resilent water system for the Town of Bascom. This would consist of a production well with appurtenances, an alternate power generating source, a ground storage tank with associated pumps, 6" water mains and fire hydrants throughout the Town, and service laterals and meters for connections to the end-users. This project will give the Town and its business and residential end-users proper fire protection and its own water system in hopes of future growth within the Town.

a. What specific purpose or goal will be achieved by the funds requested?

The project will provide the proper fire protection throughout the Town, give citizens an adequate power-resilient water supply, and allow for future growth opportunities.

b. What activities and services will be provided to meet the intended purpose of these funds?

The construction of a power-reliable water system will supply water throughout the Town using 6" water lines. Fire hydrants will be placed properly throughout.

c. What direct services will be provided to citizens by the appropriation project?

The completed project will provide a clean, reliable, and power-resilient water system with adequate capacity for public consumption, fire protection, and future growth.

The managed water system will offer greater appeal for business relocation/establishment providing more job opportunities and economic growth.

The entire Town of Bascom will gain immediate benefit from the water system. Neighboring residents may subsequently gain connection to the Towns water system. Approximately 100 - 200 residents.
