a. What specific purpose or goal will be achieved by the funds requested?

This project will replace very old and deteriated water lines, which require City to cut into pavement damaging the integrity of Market Street. The project also addresses water inflow and infiltration into the City's waste water system. The existing sewer lines are over 80 years old and require repair and replacement.

b. What activities and services will be provided to meet the intended purpose of these funds?

Engineering Services to identify the planning and scope of the project along with drafting of the deliverable for the proposed project. The construction activities associated with replacement of infrastructure and Inspection services during construction.

c. What direct services will be provided to citizens by the appropriation project?

Direct services provided as a result of this project are water and waste water services along with roadway improvements which will be done once water and sewer improvements are complete.

d. Who is the target population served by this project? How many individuals are expected to be served?

The entire population of Jackson County (48,599), will be served, in that the City's downtown area serves both in town and out of town citizens with multiple services and goods. The City has the only shopping district within the County with services described. It should also be noted Jackson County, the City of Marianna has been designated by the Governor as a Rural Area of Opportunity, (RAO) formally Rural Area of Critical Economic Concern (RACEC).

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected outcome is to have an infrastructure system that meets all Federal, State and Local Code requirements for health and safety concerns. The primary way of measuring performance is to have the City's Water and Waste Water Divisions provide monthly water loss reports along with an infiltration and inflow report showing any decrease in waste water flows at our waste water treatment plant. The project will also provide measured improvements to the infrastructure within the RAO designated community allowing for additional water and waste water capacity in our downtown business district.

for failing to meet deliverables or performance measures provided for the contract?

The contracting agency, City of Marianna will establish a Critical Path with date specific targets for pre-development. Once bids are received and warded for the project, the contract will have specific contract completion dates, if not met contractor will be subject to Liquidated Damages, assessed on a daily basis.
