#### 4. Project/Program Description

To renovate the 29 acre Jackson County Agriculture Center grounds following the devastation caused by Hurricane Michael. The center is available for use to the public 24/7 to fit an event's needs featuring 64 RV hookups, overnight horse stalls, restrooms, showers, indoor auditorium, covered arena, outdoor show arena, and ample parking. However, many of the services have been severely limited due to storm damage. The center lost 4 of its 8 barns among other structures. The renovations would allow the Ag. Center to host large scale rodeo events both indoor and outdoor while providing suitable animal enclosures to allow for overnight livestock stays. The project includes the demolition of existing structures, site prep/foundation, install new barn (80x180x14), electrical/water, infrastructure (for new barn), install new bleachers for arena, cow panels/chutes for arena rodeo upgrade, livestock stalls for new barn, new announcers booth, outdoor arena improvement (panels, bleachers, lighting)

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The improvements to the Ag. Center would elevate the grounds to a top of the line agricultural facility that can accommodate events such as Rodeos, Dog Shows, Family Reunions, Festivals.,Banquets,Livestock Sales, Wedding Receptions,Horse Shows, Barrel Racing, and Team Roping events. All of which serve to enrich the community and continue to preserve the largely agriculturally based heritage of Jackson County. These improvements would also help to revitalize the local economy of Jackson County as we continue to recover from the impact of Hurricane Michael and the Covid-19 Pandemic.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The Jackson County Ag. Extension office, Ag. Facilities Manager, and Procurement Officer will work closely together to facilitate the improvements to the grounds by lining up large scale purchasing, procuring architectural services, and hiring general contractors to complete the necessary installation work.

#### c. What direct services will be provided to citizens by the appropriation project?



The 29 acre multi-purpose facility is managed by the County and is available for use to the public 24/7 to fit an event's needs featuring 64 RV hookups, overnight horse stalls, restrooms, showers, indoor auditorium, covered arena, outdoor show arena, and ample parking. The area also serves as a major draw for our tourism industry attracting larger events such as barrel racing and the circus. The center provides a recreational outlet for the citizens of Jackson County.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The project will primarily serve the citizens of Jackson County (est. population 48,000). Additionally, with the improvements the center will be able to host larger events attracting major sponsors and attractions from across the Country.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Increased revenue from increased capacity, enriching the cultural experience of the citizens by providing a safe outdoor recreational space for individuals and organizations to host events, a new livestock storage barn and arena improvements will allow the center to host larger events such as rodeos which are major draw for businesses/investors in the community and across the U.S., especially since the rodeos will not be prevented by rain events. Increase in tourism by expanding animal housing capacity.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

De-obligation of funding, failure to request additional funds in the future.
