The current facility suffered significant damage from Hurricane Michael in 2019 when the facility had to be closed due to water damage. The county is currently paying \$2,000 a month in rent to accommodate staff. The new facility will enhance the programs and events, including ag-related programs, that can be offered in the county.

12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

For the construction of a UF/IFAS Extension facility located next to the Holmes County Agriculture Center. The current facility suffered significant damage from Hurricane Michael in 2019 when the facility had to be closed due to water damage. The county is currently paying \$2,000 a month and \$24,000 a year in rent to accommodate staff. The new facility will enhance the programs and events that can be offered in the county.

b. What activities and services will be provided to meet the intended purpose of these funds?

Currently, due to the state of the facility and its inability to serve the needs of attendees, large educational events are often hosted outside the county. Large groups are often encouraged to seek other facilities but the new facility will allow Holmes County to host these events again.

c. What direct services will be provided to citizens by the appropriation project?

The new extension building will provide space for the community events, including agriculture, family and consumer science, horticulture, community development, as well as youth programs, specifically through its 4-H system.

d. Who is the target population served by this project? How many individuals are expected to be served?

A wide section of the population will benefit, including the elderly, jobless, at-risk youth and high school and college students. Approximately, over 1,000 individuals are expected to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The new facility will allow for telehealth services to be provided which will enable patients to receive essential healthcare services locally. These services will provide a tremendous benefit to the local community.



f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The county will award the contract through a bid process and the bid documents will spell out the liquidated damages for project overruns.
