4. Project/Program Description

A new joint use multipurpose arena/facility located at the Saint Leo University Campus in St. Leo, Florida that will serve Pasco and Hernando County. This new, smart facility will feature a 12,000 seat arena/multipurpose facility that will serve as a venue for graduations, commencements, sporting competitions, concerts, conferences and other large scale gatherings and events. There are no other indoor facilities of this size and scope in Pasco or Hernando Counties. The facility will serve Saint Leo University but will be a joint use facility serving the 46 high schools located in Pasco and Hernando counties and other citizens of these counties. Pasco County had a 2.6% rate of growth in 2021 and is the 17th fastest growing county in Florida. Hernando County experienced a 1.69% rate of growth in 2021. The citizens of Pasco and Hernando Counties, and community members of Saint Leo University will benefit greatly from this joint use multipurpose arena/facility.

The expected benefit is to provide a joint use multipurpose facility to be utilized by approximately 785K citizens of Pasco and Hernando Counties. This will be measured by counting the number of attendees at events held in the venue and by intake information collected from clients/residents who book events in the facility.
