### 4. Project/Program Description

Northwest Behavioral Health Services is requesting \$1,000,000 to expand two programs: (1) 24/7 Trauma Counseling & Trauma Stabilization for children, young adults and Veterans who have witnessed a traumatic event (suicide, homicide, etc.) within 60 minutes of the incident being reported to the Jacksonville's Sheriff's Office; and (2) Face-to-face consultations for veterans and families who have witnessed recent traumatic events. Funds will be used to develop alternatives to involuntary hospitalization and provide coordination of needed services. Northwest will also provide educational workshops and support groups focused on bullying, gang related activity, victims of evictions, and suicide prevention.

#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

This allocation will support and expand the unmet behavioral health needs of at-risk youth, young adults, and Veterans and their families throughout Duval county. The purpose of this funding is to reduce the long-term mental health impacts of witnessing or experiencing gun violence; family trauma-related to suicide; home evictions; and job loss and to reduce admissions to Crisis Stabilization Units.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

24/7 Trauma counseling & Trauma Stabilization for children, young adults and Veterans who have witnessed a traumatic event (suicide, homicide, etc.) provided within 60 minutes from the time incident is reported to the Jacksonville's Sheriff's Office. We also provide educational workshops and support groups focused reducing bullying, gang related activity, victims of evictions, and suicide prevention.

#### c. What direct services will be provided to citizens by the appropriation project?

Provide face-to-face consultation (therapy, mental health counseling, etc) for children, young adults, Veterans and families who have witnessed a traumatic event. Assess, deescalate the crisis, determine the level of care necessary to meet their individual needs. Develop alternatives to involuntary hospitalization and coordination of needed services.

#### d. Who is the target population served by this project? How many individuals are expected to be served?



Intend to serve 700 persons. Includes elderly persons; individuals with poor mental and poor physical conditions; jobless persons, economically disadvantaged persons; at-risk youth; homeless; developmentally disabled; physically disabled; drug users; preschool students; grade school students; high school students; University/college students; currently or formerly incarcerated; drug offenders; victims of crime; along with veterans and their families.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Improving mental health by providing psychological first aid to individuals in crisis, experiencing gang-related activities and loss of a love one or family member. Improve quality of education by providing outreach and information and referral services to children, teens and adults (up to 35y) to improve MH awareness and accessibility for students who are failing in classes and educational training programs due to trauma crisis, events, issues, etc. While also reducing substance abuse through trauma crisis and divert youth from the criminal and juvenile justice system.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties

#### for failing to meet deliverables or performance measures provided for the contract?

If there is an area in which Northwest Behavioral Health Services, Inc. is deficient, it is suggested that a corrective action plan be implemented and monitored to ensure that any deficient areas are corrected timely. Northwest Behavioral Health Services has worked with the directed state agency during the current year to ensure that current funding meets the required goals and brings value back to he community while achieving the expected performance measures.
