Significant efficiencies and economies of scale are gained with the construction of a transfer station wherein route trucks can take their loads to a centrally located station and have it combined with loads from five or more other trucks, then the single tractor trailer takes the combined load to the landfill.

The use of a transfer station reduces the number of truck miles driven per day by trash collection vehicles on County roads and state highways. Fewer roadway miles driven is safer for traffic, uses less fuel, reduces wear and tear on pavement and is better for the environment.N/A is not considered a valid response. Reduced maintenance and repair costs for the collection fleet will reduce costs, which helps hold down rates for customers.
