Research indicated that to replace older adult gang members who are incarcerated, gangs often try to recruit youth. Youth often succumb to these efforts at early ages.

Agape Enrichment Academy has worked with school-age children and youths and elderly adults, while using the approved evidenced based prevention curricula, which encompasses a broad range of focus areas including academic support, mentoring, youth positive development. The activities in which children and adults engage while outside of school hours are critical to their social and emotional development.

Elderly persons, Persons with poor mental health, ¿At-risk youth, Developmentally disabled, Physically disabled, Preschool students, Grade school students, High school students. 101-200 in the target population are expected to be served.

Encourages youths to make good choices and alternatives to using substances in dealing with life stresses. Measure by questionnaire / surveys; observation; referral and/ or face-to-face meeting.
