The project scope includes the construction of a new stormwater collection system to improve the recurring flooding issues within the project area. The storm drainage facilities include installation of catch basins, manholes, pipes, skimmers, check valves, flap gates and Riprap Headwalls. In addition, it will include driveway restoration, pavement restoration, milling and resurfacing, pavement markings, swales construction and sodding of swales as necessary and other miscellaneous improvements.

The money was used for a combination of expenses such as mortgage foreclosure and rental eviction programs, Emergency Order compliance enforcement, PPE Expenses, Cleaning/Disinfection, Public Information, Public Safety Payroll, Facilitate Compliance, Residential Assistance, Small Business Assistance, and Community Programming. The Town is also anticipated to receive \$17 million in American Rescue Plan funds.

With rainfall attributed to Tropical Storm Eta, this area amongst others in the Town of Davie were flooded and streets left impassable for residents and public safety personnel. This project proposes to improve the drainage infrastructure in the Little Country Estates community. Our goal is to be proactive regarding the issue of flooding within this neighborhood before it poses more undue hardship on the residents.

- Protection of each catch Basin or Inlet with the installation of Geotextile Fabric.
- Installation of Turbidity Barrier in the corresponding dredge or fill areas.
- Installation of Floating Turbidity Barrier at each water outfalls or Stream or Tidal Creek.

Street Sweeping as needed.

c. What direct services will be provided to citizens by the appropriation project?



Significant reduction in flooding; protect resident's homes; accessibility for residents to get needed resources; accessibility for public safety during and after severe rain events; protection of livestock and agricultural facilities located within this area.

d. Who is the target population served by this project? How many individuals are expected to be served?

Neighborhood West of Hiatus Rd, East of SW 118th Av., North of SW 26th St. and South of SW 15th Ct.

Size of Area receiving the benefit: 237 acres

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Upgraded drainage system, outfalls, regrading of swales, and milling and resurfacing.

The Town would consider requiring liquidated damages if the project was not completed within the project timeline.
