**1. Project Title** The UCF Para-professional-to-Teacher Pipeline Program

### 4. Project/Program Description

To begin to address the ongoing teacher shortage in Orange County, the University of Central Florida (UCF) - working in partnership with Orange County Public Schools (OCPS) - seeks to establish "The UCF Para-professional-to-Teacher Pipeline Program." This program would allow UCF to recruit para-professionals who currently work in the OCPS district at Title I schools and who aspire to earn a Bachelor's Degree in Education. Program participants will have their tuition costs covered while continuing employment at their current school to avoid any loss of income while working toward earning a degree. Despite an ongoing and concerted recruitment effort, OCPS currently has had 158 teacher vacancies across the district for the 2021-22 school year. This program would enroll up to 80 participants as a way to significantly address this teacher shortage.

### 12. Program Performance

## a. What specific purpose or goal will be achieved by the funds requested?

The purpose of this initiative is to address the teacher shortage in Orange County. UCF, working in partnership with the OCPS, seeks to establish "The UCF Para-professional-to-Teacher Pipeline Program." This program would allow UCF to recruit para-professionals who currently work in the OCPS district at Title I schools and who aspire to earn a Bachelor's Degree in Education. These program participants will have their tuition costs covered while continuing employment at their current school to avoid any loss of income while working toward earning a degree. The project would enroll up to 80 students as a way to significantly address the 158 teacher vacancies recorded in the district for school-year 2021-22.

## b. What activities and services will be provided to meet the intended purpose of these funds?

Para-professionals in Title I schools will be offered the opportunity to earn a Bachelor's Degree in Education. Tuition costs will be covered by this funding request. Laptops and textbooks will be provided to each program participant. Also, tutoring services will be offered for participants desiring help to prepare to become certified. Certification exams and subject areas test costs will also be covered. Each program participant's current employment will continue - avoiding income loss as the participant earns a degree. One Program Coordinator - hired by UCF - will oversee the program.

## c. What direct services will be provided to citizens by the appropriation project?



Up to 80 para-professionals will receive support to obtain a Bachelor's Degree in Education through "The UCF Paraprofessional-to-Teacher Pipeline Program." All para-professionals currently work in Title I schools, do not have a teaching credential, and face numerous financial and professional barriers. This program will remove those barriers and positively impact teacher vacancies in Orange County.

### d. Who is the target population served by this project? How many individuals are expected to be served?

Para-professionals currently working at Title I schools within OCPS.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

### be measured?

Benefits: UCF will operate a pipeline program for para-professionals to earn a Bachelor's Degree in Education. Up to 80 para-professionals will be eligible for this program. All program participants who obtain a degree will be offered employment as a classroom teacher in Orange County. Program participants who earn a Bachelor's Degree in Education and accept a position as a classroom teacher will see their earning potential improve from an average of \$29,836 to a starting salary of \$47,500. Outcomes: Up to 80 para-professionals who obtain a Bachelor's Degree in Education will receive employment as a classroom teacher at a Title I school in Orange County based on employment contract records. A new cohort of para-professionals will be selected to complete the pipeline project and assisted as they work toward earning a Bachelor's Degree in Education and certification to teach based on coursework records. Payroll records will be used as documentation of increased earnings.
