Once fully restored, ongoing maintenance will be necessary to protect the native habitat and dynamic ecosystem within the riverine system; maintain enhanced flow; reduce opportunities for flooding. Funds were expended by 12/31/2020 and supported the following: \$12.5M small business grants; \$22M individual assistance grants; \$4M towards economic recovery initiatives (tourism, SSC, Central FL Zoo); \$41M towards public safety, service, and health (SCPS, Seminole's seven cities, Constitutional Offices, FDOH and COVID-19 response efforts); \$2.9M to area not-for-profit organizations.

Ongoing improvements in water quality, biological diversity and ecology, resulting in enhanced recreational use (measured by monitoring of water body by FDEP Numeric Nutrient Criteria, water chemistry, and biological standards); prevention of fish kills, toxic algal blooms, etc. (measured by habitat assessments and monitoring); long-term improvement of environmental recreation and use of the Little Wekiva River (measured by monitoring recreational use of the Little Wekiva River); and ongoing reduction of nutrients and other pollutants from reaching the Wekiva River (measured by ongoing water quality monitoring and habitat assessments).
