12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

These funds will be used to expand the scope of the United Way Suncoast's financial stability and financial education work. Specifically its banking, tax preparation, and financial coaching programs. It will strengthen the linkages between these successful programs. The goal of the project will be to amplify the positive impact of these efforts, and to ensure that clients are connected to the full spectrum of the United Way Suncoast's financial stability supports.

b. What activities and services will be provided to meet the intended purpose of these funds?

Funding will be used to expand United Way Suncoast's BankOn, Volunteer Income Tax Assistance (VITA) and financial coaching programs. Through partnerships with local institutions, BankOn provides access to safe, affordable banking products. VITA utilizes certified volunteers to provide free tax preparation to low-income taxpayers. Financial coaching helps individuals plan for and achieve their financial goals.

c. What direct services will be provided to citizens by the appropriation project?

Additional funding will allow BankOn to connect with more financial institutions and increase awareness about the program, helping more people benefit from fair banking. VITA will also be able to prepare more returns, bringing millions of extra dollars into the community. Finally, clients will have expanded access to financial coaching services, which will help them attain long-term stability.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for this project are the many families within United Way Suncoast's service area (Pinellas, Hillsborough, Sarasota, Manatee and DeSoto counties) that are struggling financially. That includes 12% of households in the region that are earning below the Federal Poverty Level, and another 31% classified as ALICE (Asset Limited, Income Constrained, Employed). That is a total of 557,372 households in the Suncoast region. The project will help provide financial stability assistance to thousands of people. UWS's goal for the VITA program alone is 12,000 individuals served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will



be measured?

One benefit of this project is that more individuals will be able to access United Way Suncoast's financial coaching program, which will educate and prepare them for financial success and stability in the long-term. The impact will be evident in the number of additional clients that United Way Suncoast is able to serve. These programs will also help bring a significant amount of money back to our community in the form of tax returns, tax credits, economic impact payments and rental assistance. The success of these efforts can be measured, in part, by the amount of dollars that are returned to families in our community that are most in need. Finally, by connecting more people with holistic financial stability support through the United Way Suncoast, additional ALICE families will be on the path toward economic self sufficiency. The collective impact of these programs can be measured by the number of clients served, as well as other associated metrics, including the number of new bank ac
