#### 4. Project/Program Description

Funding will be used to support development of an urban core campus in West Palm Beach that will offer globallydistinctive, top-tier, interdisciplinary and unique graduate, professional, and executive education taught by world-class faculty. The curriculum will be co-created with business and industry to serve their evolving needs to build the state's talent pipeline in highly competitive fields and bolster economic development and opportunities. Core competencies are being developed with initial involvement of UF's colleges of engineering, business, and law, and will include AI, Data Analytics, Cybersecurity, and Fintech. The campus will be located on land donated by the city, county, and a private landowner.

#### a. What specific purpose or goal will be achieved by the funds requested?

At the request of local business and community leaders, UF plans to develop an urban core campus in West Palm Beach that will cultivate a critical mass of FinTech, Cybersecurity, and Data Analytics expertise strategically located in the heart of West Palm Beach. A goal is to support Florida's burgeoning high tech economy.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

UF will work with various partners across the public and private sectors to develop a campus and curriculum, lease facilities as appropriate while that development is underway and afterward, hire faculty and student support professionals, explore collaborative education and innovation opportunities with local education/research institutions (including but not limited to Florida Atlantic University, Palm Beach State College, Palm Beach Atlantic University, and the K-12 system), and provide other functions to help Florida deliver on the promise of the opportunities that lie ahead.

#### c. What direct services will be provided to citizens by the appropriation project?

World-class, unique education that helps retain and attract talent and jobs will offer a variety of direct and indirect benefits. The primary direct services will be education and related support. Initial academic programming is expected to focus on UF's colleges of engineering, business, and law.

#### d. Who is the target population served by this project? How many individuals are expected to be served?



The target population includes potential graduate, professional, and executive education students living in Florida, those attracted to do so by opportunity, and those who might otherwise leave our state for other economic centers. The target population also includes current and future employers in need of talent and collaboration partners and state and local governments and communities that will benefit from economic expansion and innovation. Although focused in West Palm Beach, the beneficial ripple effects should be felt in every corner of Florida for many decades to come.

Measures of specialized degree programs, certifications, internship opportunities, research and collaboration, graduation rates, job placement, and growth of relevant industries.
