12. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

This project will replace 9,000 feet of existing sewage force main from the South Street lift station to the Osprey Water Reclamation Facility. The piping along Indian River Ave is thinned walled PVC pipe and has had many failures that impacted the Indian River Lagoon. It will also replace the portion of pipe that failed during Christmas of 2020 causing a sewage spill of over 7 M gallons. Completion of the project will protect the Indian River Lagoon and provide reliable sewer service to existing and future customers.

b. What activities and services will be provided to meet the intended purpose of these funds?

The construction of the sewage force main will provide multiple jobs in the local area.

c. What direct services will be provided to citizens by the appropriation project?

Once complete the new force main will secure sewer service for a large portion of northern Titusville and along the Indian River Lagoon. The project will also allow for additional growth and new customers in the downtown Titusville area.

d. Who is the target population served by this project? How many individuals are expected to be served?

This sewage force main serves the majority of the Osprey Water Reclamation Facility Basin in Northern Titusvile that totals approximately 20,000 residents.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Replacement of the existing sewage force main will reduce the risk of sewage overflows to the Indian River Lagoon thereby improving surface water quality, wastewater management, economic activity, and will enhance and improve environmental health. These benefits can be measured by a reduction in the number of sewage overflows from this sewage force main.
