Staff will manage the usage of the facility and recruit, book, and schedule local and national/international youth, amateur, and/or professional baseball/softball organizations and other community groups, event organizers, etc., to maximize the usage and benefits of the facility.

#### c. What direct services will be provided to citizens by the appropriation project?

Sports training and baseball/softball playing fields and facilities to be utilized by youth, amateur, and professional organizations as well as the citizenry at large.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The local community will be served with sports, recreation, and event entertainment facilities. Economic benefits will benefit the larger population beyond those directly participating in the use of the facility, through tourism and visitor spending from out-of-county and out-of-state.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project will provide sports and recreation facilities and other events entertainment and will also benefit the larger community - most directly the tourism and hospitality industries - by bringing visitors and tourism to the community. Measurement metrics will include the number of event days and attendance annually, estimates of out-of-county and out-of-state visitors and tourism generated, and economic impact estimates.
