### 4. Project/Program Description

This is a long-term, multi-phase expansion plan to develop the museum's potential as an education and research facility that will preserve agricultural history and improve the future of the industry while providing an entertaining experience. The Florida Agricultural Museum expansion plan, once actualized, will guide visitors through more than 400 years of history chronologically to include the important influences on Florida agriculture of the Timucua Indians, Spanish, early pioneers, plantations, agri-business work yards, concluding with anticipated future endeavors and a wildfire education zone. It will also have a two-story visitor center that will include a welcome lobby and admissions, exhibition area, gift shop, café, offices, classrooms, boardroom, and a hydroponics display.

### a. What specific purpose or goal will be achieved by the funds requested?

To develop the museum's potential as an education and research facility that will preserve agricultural history and improve the future of the industry while providing an entertaining experience. The Florida Agricultural Museum expansion plan will guide visitors through more than 400 years of history chronologically to include the important influences on Florida agriculture.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The Florida Agricultural Museum will be an educational destination for the millions of tourists coming to Florida each year; students of public, private and homeschools; locals wanting an educational and entertaining experience; and researchers looking for ways to improve production of agriculture through advanced technology.

#### c. What direct services will be provided to citizens by the appropriation project?

They would start in the welcome center with displays, demonstration areas, classrooms and a gift shop. Visitors would meander through the villages and learn about agriculture of the past, present and future in keeping with the mission. There will be zones within the villages for learning opportunities and interactive elements. Every industry in Florida's agriculture would be represented.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes students, tourists and visitors from around the State of Florida and potentially across the U.S. It is expected that annually more than 150,000 could visit the Florida Agricultural Museum.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will



#### be measured?

This project will revitalize and improve the State of Florida Agricultural Museum allowing us to realize its full potential. There will be health, educational, and research benefits to visitors, students and researchers learning about this industry, as well as having a major economic impact for Flagler County which will have a resounding affect across the State of Florida. These outcomes will be measured through surveys, feedback, annual statistics, revenue and annual local tourism tax from hotel stays.

The Florida Agricultural Museum would not appropriate any further funding until deliverables and performance measures required for the contract were met.
