4. Project/Program Description

This project request is to construct 5 connector roads in a growing area of west central Pasco County, build a 4-lane road northwest in the same area, build a pedestrian bridge/overpass over a portion of the Ridge Road extension, and install the appropriate infrastructure for water, stormwater, and wastewater along the constructed roads, including Ridge Road and Sunlake Boulevard. The area is being developed as a live-work-play community to include homes, restaurant and retail space, trail and green space, and an innovative business and research district. The county is requesting assistance to construct these transportation and facility infrastructure improvements in the area, creating accessibility from Sunlake Boulevard, the Ridge Road extension, and SR 52.

The development of this live-work-play community will enhance economic development and job opportunities in the county.

The target population is 75,000 people that live in the vicinity of this rapidly developing area and the thousands of residents of Pasco County and the surrounding counties that will live, work, and/or play in the new developments.

The construction of the roadways, intersections, overpass, and associated infrastructure is a critical element in providing the opportunities for future job creation and economic development in Pasco County. Additionally the addition of new recreation opportunities will provide an outlet for residents to exercise and be healthy. These outcomes can be evidenced through the increase in jobs, available living spaces, tax base, and available recreational space.
