The combined length of Port Manatee's Berths 4 and 5 is only 1,200 feet which is not enough area to support two operations at the same time. Berth 4 is to be extended by 600 feet in order to be able to meet the increased business demand and facilitate two ships simultaneously. The seagrass mitigation component of the project does not qualify for a stand alone grant and since the project cannot be built without the mitigation, the seagrass is included as a general navigation feature of the project.
