As owners of the historical Hotel Jacaranda, the SFSC Foundation seeks to upgrade critical components within the hotel that are crucial to the continuation of services and operation. Funds will be used to update antiquated electrical wiring found in over 50% of the hotel that is still in operation to date, update plumbing to alleviate sediments and rust, replace rotten window frames on the student residence side of the hotel, and update and repair the only elevator in the hotel.

#### a. What specific purpose or goal will be achieved by the funds requested?

The Hotel Jacaranda provides space for training and testing with on-the-job training to culinary students enrolled at South Florida State College, a dormitory for students enrolled at SFSC, functional hotel and restaurant, and leased spaces for businesses. Upgrades will provide necessary improvements to the emergent needs our students and citizens experience daily.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The Hotel Jacaranda is a 100-year-old historical hotel that is the centerpiece of downtown Avon Park and contains a restaurant, hotel, and commercial space that serves the community as well as providing classroom and dormitory space for SFSC students. Improving the electrical, plumbing, window frames and elevator components will increase the safety measures needed in operating a hotel/restaurant and student residence facility.

#### c. What direct services will be provided to citizens by the appropriation project?

Necessary improvements will ensure the safety and wellbeing of our citizens who will benefit from these services through their dining experience, hotel stay, and variety of commerce located in the hotel. Culinary students will continue to advance their culinary skills through the program offered at the hotel. Student Residents will experience modern amenities such as updated plumbing.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Approximately 34,000 people visit the Hotel Jacaranda on a annual basis. This population includes elderly, local businesses, community members, visitors from out of the region/state/country, students, and children.
