a. What specific purpose or goal will be achieved by the funds requested?

The major goal of the project is to expand our vocational programming & support services to be able to accommodate more individuals living in the counties of Baker, Clay, Duval, Nassau, & St. Johns with intellectual & developmental disabilities.

b. What activities and services will be provided to meet the intended purpose of these funds?



NFSSE will be able to serve more transition and postgraduate students in 3 vocational programs: Barkin' Biscuits (pet bakery / dog treats made with all natural ingredients), Art With Soul (art studio where students create and sell art made with a wide variety of art mediums), and Berry Good Blooms (farm fresh flowers are grown on the farm and harvested to create floral bouquets for sale). These vocational programs teach employable skills to the students in the program and will enable them to seek compensated employment in the community.

c. What direct services will be provided to citizens by the appropriation project?

NFSSE provides vocational training programs that teach employable skills like packaging dog treats, growing and harvesting flowers, and creating art (to name a few). Students have the opportunity to learn a variety of transferable skills that would result in compensated employment in our Community Integrated Employment program.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is 150 transition students and postgraduates of NFSSE. These are individuals with developmental and intellectual disabilities.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

NFSSE will be able to serve more students in the target population who otherwise have to seek out alternative vocational opportunities that often do not cater to individuals with developmental or intellectual disabilities. The expected benefit or outcome is compensated employment.
