4. Project/Program Description

Founded in 2012, Northeast Florida Women Veterans, Inc. is focused on ensuring women who served on Active Duty, National Guard or Reserves and their children, transition into the civilian community with the tools and resources they need to become self-sufficient. "Women Veterans Ignited" is a response to the rise in suicide among women veterans and the decline in economic stability. Services provided are financial assistances, workshops, emergency shelter, counseling, food, transportation, and case management. Clients/participants are followed for up to 12 months after last service. 85% of our clients are overcoming military sexual trauma and or PTSD. Our "safe space" allows them to open up and begin to heal as they get help with basic needs and other services. In addition, we provide proactive personal and professional development programs so that women who become self-sufficient, continue to thrive.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Funds will support all programs within the organization. These programs provide holistic and wrap-a-round services for women veterans and are the only of it's kind in the state of Florida. The goal is to help women veterans with personal and professional development, help stabilize at-risk or homeless women veterans and their children, and provide resources for their success. These programs help to combat suicide and provide options and resources to make healthy decisions for their lives.

b. What activities and services will be provided to meet the intended purpose of these funds?

HerTOTALWellness is 6 weeks of workshops on body, mind and economic empowerment. HerSPACE provides temporary shelter for 7 women and children up to 6 months and case management. HerBIZ allows women veterans to spend 6 months in workshops and hands-on assistance to help them start their own business. Operation Hand-UP provides clothing, food, transportation, counseling, and financial assistance to women veterans and their children.

c. What direct services will be provided to citizens by the appropriation project?

All the services noted in section b., will be provided to citizens who have served in the military. Our services are also extended to daughters of veterans age 18-24. Each program participant will receive workshops from industry experts. In addition, participants and clients needing financial assistant will be case managed with goals to achieve. Counseling is provided as well as food and transportation. Those in our shelter are case managed, assisted with finding stable housing and employment. Resource fairs will be provided for rural areas with the collaboration of other community partners and the VA.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project are women who have served in the military and their children. We also accept daughters of veterans age 18-24 into our programs. With this funding, we expect to serve 400-800 clients/participants during this funding period.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

There is a pre and post assessment administered for all of our programs. We also do a one-on-one intake with clients. These two methods allow us to collect needed data.

100% of eligible veterans will be connected to the VA Health System.

95% of women veterans requiring mental health services will be connected to a counselor.

95% Graduation Rate for women veterans enrolled into one of our programs which all provide resources to economic self-sufficiency.

95% Homelessness or at Risk of homelessness will obtain stable housing

75% of those seeking employment will find employment while a resident in shelter.

85% completing HerBIZ will be ready to launch their own business
