#### 4. Project/Program Description

The project consists of the installation of approximately 1,700 linear feet of exfiltration pipes in several areas surrounding Memorial Regional Hospital. The project will alleviate flooding at the entrance to the hospital, along major access routes to the hospital, and along evacuation routes vulnerable to increased flooding due to the impacts of climate change. The pipes will allow storm water to be collected and then slowly discharged into the ground through coarse aggregate, permitting natural filtration. The technology adds significant water quality treatment for the storm water flooding in the area and complies with storm water runoff regulations in urban areas where space is limited.

This project will reduce flooding risk on roadways leading to the Hospital and evacuation routes vulnerable to increased flooding due to the impacts of climate change.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The Design and Construction will include upgrades to the storm water management system for the neighborhood around Memorial Regional Hospital.

#### c. What direct services will be provided to citizens by the appropriation project?

The primary service provided to citizens will be increased drainage management and improved water quality treatment, thus reducing flooding risks and pollution.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The project targets the general population of the City; over 800 people in the target population are expected to be served.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project will result in property owners and the general public having reduced risk of flooding within the project area as well as improved groundwater quality by adding natural filtration to the storm water runoff before recharging the groundwater with better quality. The method for measuring the outcome will be the quantity of storm water collected by the new exfiltration system and the quantity of storm water naturally filtered through the exfiltration system.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Contracts will include enhanced liquidated damage provisions with amounts based on the most current City Standard Specifications, Payment and Performance bonds, and retainage.
