The goal is to enhance the American Legion Mission to provide volunteer services in our communities, to mentor youth, to advocate patriotism, to honor and support fellow service members, veterans and other service members in the community.

b. What activities and services will be provided to meet the intended purpose of these funds?

Services include, but are not limited to, scholarships, schools medals program, ROTC and JROTC support, Boys and Girls State, Boys and Girls Scouts, Boys and Girls Clubs, and County 4-H. Additionally, we support community Independence and Veterans Day activities, retirement home visits, funeral honors, PTSD awareness and suicide prevention.

c. What direct services will be provided to citizens by the appropriation project?

The additional space will create a secluded area for individual counseling by the Post Service Officer and the County Veterans Service office. This service will be for the veterans and their spouses on VA medical benefits, pensions and survivor and funeral benefits. These services will be available to all veterans in Seminole County and surrounding areas. In addition to individual counseling, the space will allow for group presentations by qualified service officers to the public and other civic organizations.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is more than the 260 members and family members of Post 243. They range in age from World War II, Korean War, Vietnam era to the Global War on Terrorism. Many of these members and family members are disabled. The additional target population is the young adults and youth the post supports to include ROTC, JROTC, the 2,400 students, faculty and family members in the twelve school medals program, Boys and Girls State, Boys and Girls Clubs and county 4H.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

With the success of community support activities, the Post has been selected as the Best American Legion Post in the state of Florida. This success has created a demand that exceeds our ability to support the community and have had to deny requests for support. The methodology and measurement of success will allow the expanded facility to not only increase the services to the target population but allow the post to host activities for the retirement homes and the other civic organizations we serve and host multiple activities at the same time. The measurement of success will be the increased number of activities we host.
