In gratitude for their service and sacrifices, our program emphasizes affording them quality housing or essential repairs. Funding will be dedicated to the construction of two new homes, rehabilitation of two homes and 15 projects focused on home fortification and resiliency through the use of hurricane impact windows and installation of new roofs.

In 2021 and 2022, Habitat for Humanity of Palm Beach County received a total of \$942,682 in PPP funds, prior to merging with Habitat for Humanity of South Palm Beach County to form Habitat for Humanity of Greater Palm Beach County. Funds were utilized to cover COVID wages and benefits to employees affected by COVID closures, and offset financial losses due to closures of our retail thrift stores.

### a. What specific purpose or goal will be achieved by the funds requested?

The goal is to bolster housing stability and safety for our community members, especially prioritizing veterans and essential employees. A veteran in Boca Raton will receive an owner-occupied rehab, while a Habitat-owned property in Lake Worth will undergo rehabilitation. Two new homes will be constructed on Lantana lots, addressing the housing needs of our hardworking essential workers. Additionally, 15 projects across the region will ensure homes are weather-resistant with roof replacements and hurricane impact windows, benefiting both veterans and essential employees.

### b. What activities and services will be provided to meet the intended purpose of these funds?

To actualize the intent of the \$700,000 appropriation, Habitat for Humanity in Greater Palm Beach County will embark on targeted construction and repair projects, giving precedence to qualifying essential employees, and veterans. In parallel, we will conduct homeownership and financial literacy training sessions, ensuring home owners are well-equipped for their new responsibilities.

### c. What direct services will be provided to citizens by the appropriation project?

The appropriation will directly support the construction, rehabilitation, and upgrade of homes, prioritizing veterans and essential employees in Palm Beach County. Qualified individuals will access quality housing, promoting stability and self-sustainability. In tandem, homeowners will benefit from insights on home upkeep and fiscal responsibility. Through these efforts, our mission is to fortify the community by ensuring our veterans and essential workers have a secure and resilient home environment.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The project's target population is essential employees and veterans within Greater Palm Beach County. Furthermore, we are dedicated to assisting families earning below 80% of the area's median income as determined by HUD. Through this initiative, we anticipate supporting 19-20 households (approximately 45 individuals), bridging the gap in housing needs across various income levels in our community.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The anticipated outcome of this project is a transformative elevation in homeownership and preservation of existing homes among essential employees, veterans, and families earning below 80% of the area median income Palm Beach County. The ripple effect will be a fortified community with stable housing for its backbone members. To gauge the project's impact, we will track the number of homes constructed and repaired and the demographics of families served. Periodic homeowner surveys will also capture satisfaction and integration metrics, ensuring a holistic understanding of the project's success and community integration.
