#### 14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The Overtown Youth Center College and Career Readiness program aims to increase student's knowledge of college and career options, providing jobs and internships and improving financial literacy. The goal is to develop youth who contribute to a thriving community with a vibrant workforce by ensuring each student is equipped with the tools to succeed, can take part in civic engagement and have the ability to impact their communities.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Services include expanding college and career readiness programming to serve youth starting in kindergarten through 12th grade, homework assistance, ACT/SAT practice, career assessment, college preparation, financial literacy and job placement. The goal is to include more intensive career exploration, improved student achievement.

#### c. What direct services will be provided to citizens by the appropriation project?

Coordinators provide continuous student support using individual case management to track progress towards post secondary goals. Services also include daily monitoring, mentoring, counseling and advocacy. Student report cards are collected directly from Miami-Dade County Public Schools to monitor the progress of the students in core academic content areas. An Individual Success Plan (ISP) is used for goal-setting and career planning 4 times per year. College and Career Readiness Workshops are provided on a weekly basis to engage high school students in their preparation for post-secondary success.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Funding serves 100 youth in grades K-12 who reside in marginalized communities throughout Miami-Dade County. Risk factors include poor performing schools, and under resourced communities which lack college and career readiness opportunities.

#### be measured?

The Overtown Youth Center Mentoring/ Student Assistance Initiative - College and Career Readiness programs provides a comprehensive pathway to post-secondary success. Benefits measured improved quality of education, enriched cultural experiences, and improved physical health. Methods of measuring benefits and outcomes include in-school individual case management, counseling, advocacy, mentoring, report card reviews and pre, mid and post assessments to monitor student proficiency in Reading, Math and Science. Additionally, enrichment and enhancement classes, exposure field trips and college focused activities and agility and strength assessments.
