# Meals on Wheels, Etc. provides healthy, nutritious meals to hundreds of seniors in Seminole County daily. The ability to continue to provide for these vital meals is in jeopardy with the present meal delivery fleet. The expected benefit is the continuance of both transportation and meal delivery services. These benefits will be measured through nutritional risk assessment and client surveys.

If Meals on Wheels, Etc. does not meet deliverable requirements, we will return funding proportional to the unmet measure. A corrective action plan will be submitted for approval. Repeat failures may result in future funding reductions.
