# 4. Project/Program Description

The City of Stuart completed its septic to sewer infrastructure project in 2020, which provided the primarily lines of connection for sanitary sewer service throughout the entirety of the city's utility service area. However, there are currently more than 700 properties within the City which have not converted to the new sewer system. A substantial amount of these residences are believed to not have yet converted due to financial burden or hardship. Each connection will include the tasking of city utility workers installing lateral connections between main sewer lines and private homes with grinder systems. Appropriated funds would be joined with local funding for direct connection assistance for property owners as incentive to abandon septic tanks for sewer systems. The City's local match for the requested state funds would likely well-exceed 50% of total costs per connection, and the City is committed towards achieving a 100% connection goal in the near future.

The City of Stuart (to date) received \$8,132,360 from the State and Local Fiscal Recovery Funds as part of the American Rescue Plan Act. Funds have been used to offset dollars spent on emergency response and overtime for personnel, Alternative Water Supply infrastructure, water/sewer infrastructure, law enforcement response to violent crimes and gun violence, community nonprofit support, dispatch and police officer equipment, streetscape improvements, and stormwater projects.

# 14. Program Performance

# a. What specific purpose or goal will be achieved by the funds requested?

The City of Stuart completed its septic to sewer infrastructure project in 2020. However, there are currently more than 700 properties within the City which have not converted to the new sewer system A substantial amount of these residences are believed to not have yet converted due to financial burden or hardship. Appropriated funds would be joined with local funding for direct connection assistance for property owners as incentive to abandon septic tanks for sewer systems over a 3-year period.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The project will design and construct plumbing connections from public sewer infrastructure to individual properties. Once a property is connected to the sanitary sewer system, the septic tank will be properly abandoned.

#### c. What direct services will be provided to citizens by the appropriation project?

Property owners will be provided the service of plumbing connections and septic tank abandonment, including the required permitting and notifications.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

More than 700 private residences (families) that are currently not connected to sanitary sewer and would be provided the financial relief requisite for their connecting. These account for the last remaining properties in Stuart to not be connected to the sanitary sewer system.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project proposal represents the City's last effort to finalize ALL sewer connections within its jurisdiction and utility service area. The City of Stuart already has both personnel and resources in place to immediately begin installation of sewer connections for those homeowners who have yet to commit. The financial incentives offered would be a one-time opportunity for holdouts to agree to switch from septic to sewer with both local and state assistance.
