The Sarasota Bradenton International Airport passenger numbers have grown over 300% from the pre-Covid numbers going from 1,300,000 annual passengers to 4,300,000 passengers. This has necessitated significant increases in public safety personnel. Additionally, all public safety dispatch and communications is handled by airport employees in a communications facility in the terminal. The airport incurred over \$2,000,000 of terminal damage during Hurricane lan, including over 15,000 sq. feet of roof being blown off the terminal ticket wing. If this had occurred a few hundred feet further north in the terminal the entire communication and emergency response area would have been inundated with water. This project is meant to preclude that from happening by providing a secure, hurricane hardened facility to ensure public safety response at all time.

### b. What activities and services will be provided to meet the intended purpose of these funds?

Police, Fire and Communications personnel and supporting equipment would be housed in the facility to ensure the ability to respond to public safety events regardless of the weather and in a coordinated manner by housing all public safety functions together. It would also contain a storage room for airport authority records to ensure the preservation of public records regardless of weather impacts.

### c. What direct services will be provided to citizens by the appropriation project?

Police and Fire, and medical response.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The airport handles over 4,300,000 passengers, plus meeters and greeters, as well as thousands of employees. This would serve nearly 7,000,000 people in its first year.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The benefit is to ensure public safety is maintained regardless of weather and provide greater efficiency by housing all public safety functions together. The outcome is measured in response times to emergency dispatches as well as the ability to operate regardless of weather and hurricane impacts.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The request is for construction funding only so only contract penalties would be if contractor went over agreed contractural timeline.
