#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Feeding Tampa Bay's FRESHforce program provides workforce development and on-the-job training to individuals with barriers to employment. FRESHforce offers courses across 3 different industries: culinary, warehouse logistics, and truck driving. These funds will support four ten-week cohorts of trainees (6 drivers/12 warehouse per cohort).

b. What activities and services will be provided to meet the intended purpose of these funds?



All candidates who come through the FRESHforce program receive a bi-weekly stipend during the 10-weeks of training and grow their employability skills, as the course implements soft skills learning, such as customer service, interviewing techniques, conflict resolution, resume writing and more; all the while, earning industry-standard certifications to enhance their job prospects post-graduation.

#### c. What direct services will be provided to citizens by the appropriation project?

Drivers receive Class B license and DOT physical. Drivers and warehouse operators receive food handlers certification, forklift, OSHA, office suite certification, employability skills, and opportunities to engage with employers. Case management and a stipend is provided to all trainees.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Individuals seeking upskilling and/or employment. Target populations might include the homeless, elderly, formerly incarcerated, drug offenders, at-risk youth, jobless, and economically disadvantaged persons. 72 slots will be created, if fully funded.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Creation of immediate job opportunities -- Upon graduation, trainees will be supported until a job is secured. 80% of trainees secure a job within 6-months of graduation; Enhanced self-sufficiency and economic activity-- Feeding Tampa Bay will train unemployed and underemployed individuals for high-paying, industry-specific jobs; Reduce substance abuse -- Studies conclude that gainfully employed individuals are less likely to abuse substances than unemployed and underemployed individuals are less likely to abuse substances than unemployed and underemployed individuals conclude gainfully employed individuals exhibit better mental health outcomes than those that are under or unemployed; New educational opportunities for jobseekers.
