Construction of a wastewater treatment package plant that will serve industrial customers within the Milton Interchange Park. WWTP will include tertiary treatment and high-level disinfection. Effluent design parameters will be in accordance with the Part III reuse requirements. Biosolids disposal will not be located at the MIP WWTP site. The effluent management program will include provisions to capture PFAS and some additional constituents of emerging concern (pharmaceuticals).

The construction of the plant will provide effluent disposal options for future industrial owners who will utilize the site for new business which will increase job availability to our current local citizens in the work force. The location of the WWTP will serve future industrial customers on 192 acres of prime industrial zoned acreage with frontage on Interstate 10 at exit 31.
