The Family Cafe is the leading source of information, resources, and networking for Floridians with disabilities. It hosts the largest statewide cross-disability event in the nation, The Annual Family Café, which connects attendees with resources and strategies they need to thrive in their communities. It also provides a platform for state agencies and policy makers to connect with the citizens they serve. The Family Café also promotes leadership among youth with disabilities through its Florida Youth Council and supports the development of local family organizations through a Family-Run Organization Movement initiative, so Floridians can access the connections, resources, and natural supports that The Annual Family Cafe offers on a local level throughout the year. This specific project will support the 25th Annual Family Cafe in June 2023, Florida Youth Council activities, and local resource development via the Family-Run Movement.

### 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The requested funding will allow The Family Cafe to support and promote the self-sufficiency and wellbeing of Floridians with disabilities. Funds will allow The Family Café to connect Floridians with disabilities and their families with information, resources, and networking opportunities, both through The Annual Family Café event, and on a regular basis throughout the year. The Annual Family Café will connect families with peers, commercial service providers, and public entities to find out what services are available to them, which best serve their needs, and how to go about securing those services. The Family-Run Organization Movement project will replicate the organization's statewide success by developing local family organizations. The Florida Youth Council program will foster leadership among the next generation of disability leaders.

### b. What activities and services will be provided to meet the intended purpose of these funds?

The primary activity that will be funded through this request is the 25th Annual Family Café. This three-day event will include approximately 200 breakout sessions; a series of keynote events; The Annual Governor's Summit on Disabilities, where attendees can interact with the Governor and the State Agencies that serve them; and an Exhibit Hall, with a range of providers, partner organizations and private vendors on hand to showcase their services and products for individuals with disabilities. Funding also allows for on-site support of local organizations through a Family-Run Organization Movement project to bolster family-run organizations to create local networks of resources and advocacy, supports youth leadership promotion through The Florida Youth Council and its Annual Youth Summit.

### c. What direct services will be provided to citizens by the appropriation project?

The bulk of the direct service provided by The Family Café comes in the form of training and resource provision through 25.5 hours of total training activity at The Annual Family Cafe as well as training through the Annual Youth Summit. The project also provides direct service to family leaders engaged in the Family-Run Organization Movement through on-site training and assistance in their communities, provides information dissemination through its website, mass email list, and social media channels, and publishes an annual resource guide called the Questions & Answers Book.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The Family Café primarily serves K-12 students with disabilities or special health care needs and their families. It is also open to other Floridians with disabilities, including transition-age youth. The 24th Annual Cafe hosted over 10,100 attendees.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The Family Café makes individuals with disabilities better equipped to flourish in the community. The project will lead to informed families better able to identify resources, engaged youth disability leaders able to lead their peers in transition to independence, and a network of local family-run organizations able to support Floridians with disabilities where they live. The Family Café collects data regarding satisfaction with The Annual Family Café through a survey tool known as the "Report Card." It offers a means to provide both objective and subjective feedback about the event. A similar survey tool is used to assess the efficacy of the Annual Youth Summit.

# f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The Family Cafe has a long-standing working relationship with the Florida Department of Education and possesses a strong understanding of the expectations related to project performance and deliverables. The Family Cafe is prepared to meet DOE's expectations, to adjust implementation plans, and provide all necessary information and documentation to demonstrate a good faith effort to meet department requirements.
