### 4. Project/Program Description

Focus Forward requests funding to enhance services for young people with developmental disabilities, which are currently constrained by limited resources. Focus Forward is an entity of the Project Focus Foundation and was founded to empower young people with developmental disabilities who have aged out of school programming. Through adult day training they learn skills that will lead to an independent lifestyle and reduce their dependence on public services. These funds would increase staffing, ensuring compliance with Florida's staff-to-client ratio and enable wider community engagement, including gym memberships, animal shelter partnerships, and other local activities. The addition of a mental health counselor would provide emotional support to clients. Funding would also upgrade facilities, introduce a computer lab, a sensory relaxation zone, and a life skills simulator module. This expansion aims to foster independent living skills and provide clients with broader experience.

Over 60% of our students are also income challenged and on free or reduced lunch, and 52%+ of our students are non-white. Lastly, 10% of our young people come from foster care or live with a grandparent, adding additional challenges.	100,000

### 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

Funding will enhance Focus Forward's services for young adults with developmental disabilities who have aged out of school programming. The program expansion will increase our reach into the community to empower young people to lead a more independent life and engage in the community. This funding reduces our young people's dependence on public services, increase their quality of life, and provide relief to Florida families.

### b. What activities and services will be provided to meet the intended purpose of these funds?

Grant funds will enable Focus Forward to enhance client services by increasing staff, ensuring safety, and offering enriched partnerships and activities, along with crucial mental health counseling for better life navigation. Increasing programming and reach of programs will produce outcomes beneficial to the state.

### c. What direct services will be provided to citizens by the appropriation project?

The state grant enables vital services that empower an often-ignored segment of the population, delivering benefits to local enterprises and financially constrained households. It effectively reduces the broader economic impact by addressing the distinctive needs associated with developmental disabilities, thereby creating a more inclusive and prosperous community for all.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The funding will support our campus of over 160+ young people with developmental disabilities and 40+ staff, their families and community at large. Our young people have IQ's under 69, 60% are on free and reduced lunch, and 52% are non white. 10% of our students come from foster care or live with a grandparent.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Improvements in physical fitness, mental health, enriched cultural experience, improved quality of education enhanced economic self-sufficiency, and a reduction in the chances of being incarcerated. The tools to measure will include skill assessments, progress reports, tracking student attendance, tracking the number of partnerships, and measuring fitness in the beginning and end of the academic year.
