#### 4. Project/Program Description

Individuals reporting opioid use are significantly more likely to be involved with the criminal justice system compared to people with no opioid use, and the level of justice involvement increases with the level of opioid use (SAMHSA). Justice-involved individuals are more likely to die of an opioid overdose compared to the general population and, drug overdose is among the leading causes of death for individuals re-entering the community, with a majority of these overdoses involving opioids. It has been estimated that 77 percent of formerly incarcerated individuals with an OUD relapse to opioid use within three months of release even after participating in a counseling program while incarcerated. STEPS proposes to operate a comprehensive Mobile Outreach program that will provide immediate access to culturally competent staff, primary health care, HIV/STI testing and medications, substance use and mental health counseling, case management and medication assisted treatment (MAT).

#### 14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



The specific purpose and goal of MOVE will be to serve as a behavioral health and primary care entry site and ultimately bridge citizens to office-based settings for ongoing care and increasing access to addiction services for people at highest risk with an Opiate Use Disorder (OUD) of near-term death. The MOVE will expand evidenced based treatment(s) to underserved populations who otherwise have no access to life saving care. The MOVE project will have more success at establishing trust and rapport with community members because staff will include those perceived as peers who are credible, and positive role models to active drug users.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Activities will be committed to working within the community in target locations that are not in proximity to brick-andmortar treatment programs. We know that criminal justice programs serve a large population that does not qualify for Medicaid or private health insurance therefore services of our traditional treatment programming will be expanded to the community to include immediate access to primary healthcare, substance use and mental health counseling, HIV/STI testing and treatment(s), case management and access to medication assisted treatment. All activities will be provided through regular site scheduling within the community and walk-ins will be accepted rather than requiring appointments.

#### c. What direct services will be provided to citizens by the appropriation project?

The project will serve as an entry point to care for indigent and under-insured citizens of Central Florida. Taking a holistic approach MOVE will reduce the stigma and barriers faced by those in the criminal justice system who are often unable to access direct services that includes primary healthcare, HIV/STI testing and treatment, substance use and mental health counseling, case management and access to medication assisted treatment due to the lack of availability of community based providers who have capacity to serve or who are unwilling to serve people who are under criminal justice oversight.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Indigent and under-insured Central Florida residents involved with or at risk of criminal justice involvement who are in need of primary healthcare, substance use, HIV/STI testing and treatment and mental health counseling, case management and access to medication assisted treatment. Given that as of 10/27/2023 there are approximately 15,600 central Florida residents on community supervision STEPS anticipates easily serving 1500 citizens per year.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

MOVE will take a client centered approach to providing access to quality safe and efficient care that through this easily accessible entry point will increase access to and retention in treatment, reduced use of the justice system by individuals with opioid use disorders and ensure continuity of care once individuals are no longer under criminal justice oversight. The MOVE services and supports being provided are critical to addressing recidivism risk factors, such as lack of stable housing, employment, meaningful daily activities, and supportive peers, as individuals with OUD return to the community.

# f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Suggested penalties include return of funds if the MOVE unit is not operational within sixty (60) days of funding being made available.
