The program will focus on providing police chiefs with an understanding of the many critical issues and with interaction they have with other police chiefs, city officials and the general public. Because of the nature of their position in the community the training will provide new police chiefs in the state of Florida with the tools and training to succeed in their positions.

The target population is the general public. 800+ individuals are expected to be served.

The outcome of the training is aimed at enhancing interaction with other police chiefs, city officials and the general public. Furthermore, the program has proven to reduce turnover, therefore providing consistency in Florida communities. Upon the review of these evaluations, the FPCA Professional Standards Committee has a role in updating or modifying training sessions, as necessary.
