#### a. What specific purpose or goal will be achieved by the funds requested?

The project helps to maintain seniors mental and physical health in a home setting in lieu of nursing homes placement or hospitalization in some instances. The programs seeks to improve the mental and physical health of Broward County senior citizens (age 60 and over) by promoting independence and encouraging involvement in the community. Through recreational and social programs and services offered at the Center, seniors receive health support, recreation, and an enhanced quality of life. The Center offers a variety of educational and cultural enrichment classes, leisure activities, trips, and tours to create a rich setting where seniors can maintain their independence and vitality while interacting with others and continue living their best lives.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The center provides a vast variety of programs, activities and events that address seniors' physical, mental, emotional, social and spiritual well-being. The funding provides additional recreational, social programs and services ranging between educational, cultural enrichment, leisure activities, trips and tours.

## c. What direct services will be provided to citizens by the appropriation project?

Funding provides recreational and social programs and services ranging between educational, cultural enrichment, leisure activities, trips and tours. Examples include:

1. Programs: Bingo, Painting with a Senior, Table Tennis, Yoga, Arts & Crafts, Stamp Club, Bridge lessons, Movie nights, Chair Dance, Chair Volleyball, Ping Pong, Rummikub, Zumba, Quilting, ESOL, Garden Club, Computer & Smart device education, Social Media classes

 Field trips: Aladdin, Cirque du Soleil, Beauty & the Beast, Wicked, Universal Soul Circus, Family Feud the Show, Health Fairs, Luminosa Chinese Lantern Festival, Sawgrass Mills Mall, Christmas Pageant, Holiday Boat Party
Special Events: Fall Festival, Halloween Breakfast, Holiday Luncheon, Valentine's Day Dance, Senior Prom

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The Center serves approximately 1,250 Broward County senior citizens, age 60 and over, recreational and social programs and services originating from Hollywood's Boulevard Heights Community Center. The facility receives approximately 125 daily guests, who participate in programs, activities and events. Expanded funding and resulting additional classes and programming can help serve hundreds of additional senior citizens who are currently not receiving services.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The program seeks to improve the mental and physical health, expose Broward County senior citizens (age 60 and over) to enriched cultural experiences by promoting independence and encouraging involvement in the community. These outcomes will be measured by attendance, participation, data, and surveys.
