Additionally, these pantries will serve as critical food prescription refill sites, supporting food insecure Floridians living with diet related disease conditions. # 14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?



Feeding Tampa Bay (FTB) will fund 30 existing and new food pantries at schools where the risk of food insecurity is prevalent, bringing groceries to students, families and school staff who may struggle to make ends meet and supporting the behavioral and academic success of students. Additionally, these pantries will serve as critical food prescription refill sites, supporting food insecure Floridians living with diet related disease conditions. Overall wellness starts with nutrition.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Feeding Tampa Bay will use these funds to purchase the necessary equipment and product, and to support the operational expenses associated with expanding the Feeding Minds Program to 30 existing and new school sites. Each school pantry adds about 75-100 families served weekly, that would not already be serviced by FTB partners, which totals about to 300-400 unduplicated individuals impacted.

### c. What direct services will be provided to citizens by the appropriation project?

Feeding Tampa Bay will expand the Feeding Minds program to 4 new counties- Citrus, Sumter, Hernando, Highlandswhile supporting existing programs and increasing a community's access to fresh groceries and nutrient-rich meals. These new sites will also be equipped to accept and fill food prescriptions.

# d. Who is the target population served by this project? How many individuals are expected to be served?

Persons with poor mental and physical health, jobless and economically disadvantaged persons, grade and high school students, homeless, and food insecure persons. Each school pantry adds about 75-100 families served weekly, that would not already be serviced by FTB partners, which totals about to 300-400 unduplicated individuals impacted. The impact to the community, when these families are considered, is greater than 800.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

Increased food distribution; Improved education -- Studies conclude the lack of access to high quality, nutritious food contributes to poor health, and that access can be both preventative and restorative for those who battle chronic and diet related disease conditions. Access to fresh groceries and nutrient-rich meals is a stepping stone to a bright future which ensures the long term health of our children and the community. Improved mental and physical health -- Studies conclude that the reduced frequency, quality, variety, and quantity of consumed foods may have a negative effect on a child's mental and physical health. They also face a higher risk of developmental problems compared with food-secure children. Feeding Tampa Bay will track the amount of food distributed and report the number of individuals impacted by the increased distribution efforts.
