It has undergone multiple repairs and due to the extremely aggressive marine environment, it will continue to deteriorate rapidly. The bridge serves as the single point of access and hurricane evacuation route to multiple households.

The bridge serves as the single point of access and hurricane evacuation route to residents in the community. Once the bridge has been replaced, residents will have a reliable evacuation route in the event of a hurricane or other significant weather event.

A collapse could cause potential harm to residents, leaving them stranded in the event of a severe weather event. Once the design and permitting have been completed, the existing bridge will be replaced with a new resilient structure.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The bridge serves as the single point of access and hurricane evacuation route to multiple residents in the island community.

Once the bridge has been replaced, residents will have a reliable evacuation route in the event of a hurricane or other significant weather event.
