a. What specific purpose or goal will be achieved by the funds requested?

The purpose of this funding request is to strategically eliminate the geographical barriers hindering students' access to crucial civic literacy and speech and debate programs. Our goal is to make these programs universally available, empowering students with vital life skills, fostering confidence, honing critical thinking abilities, and refining communication proficiency. Moreover, this initiative aims to create a platform for students to interact with diverse perspectives, encouraging civil discourse, and enhancing their understanding of civics. The FDI is committed to serving every school district in the state and persistently expanding its reach to encompass every school therein.

b. What activities and services will be provided to meet the intended purpose of these funds?

We'll use the funds to back crucial activities: resources in schools without programs, support those with programs, provide affordable academic competitions, and, most importantly, promote civic literacy through speech and debate participation.

c. What direct services will be provided to citizens by the appropriation project?

FDI is the educational support organization for speech and debate coaching, student training, judge training, and competition standards. We'll serve 300+ schools in all 67 counties this school year.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project is grade school and high school students across the state of Florida, encompassing both urban and rural communities. The Florida Debate Initiative aims to reach over 300 public schools through its programs, serving thousands of students.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit of this project is to equip students with confidence, critical thinking, and communication skills through speech and debate. Serving as their advocates, students will engage in civil discourse, exposed to diverse perspectives, cultures, and backgrounds. Speech and debate acts as an educational equalizer, expanding learning beyond classrooms, fostering the ability to critically analyze information. The project aims to deepen understanding of civics, our system of government, and appreciation for the U.S. Constitution and Bill of Rights. The Florida Department of Education will establish the outcome assessment process, ensuring the project's effectiveness in achieving these educational goals.
