In 2020, Columbia County had purchased 500 acres of land for a flat fields facility. This appropriations request will match the \$3 million in reserves to begin construction of infrastructure such as roads and utilities and the start of construction of flat fields for soccer in the park. The park is set to be a regional hub for tournaments that will provide recreation for local residents, but will also increase economic output in North Central Florida. Part of the 500 acres will also be used for conservation and other recreation uses.

Columbia County received \$2,000,000 in CARES Act Funding that was allocated towards the NFMIP WWTP to shore up an existing grant. \$13.9 million of ARPA money was divided up as follows: \$6.2 million for Fort White water projects,\$4 million for the NFMIP WWTP, 1.7 million in business assistance, 679k for individual assistance, and \$1 million for emergency home repair. An additional \$729,853 came from the LCTPA portion of funding that was used to purchase a building for additional county offices.
