### 4. Project/Program Description

This project is based on the goal to decrease the total number of Public Safety Answering Points (PSAPs) into a single facility that co-locates the services currently provided in separate facilities by the Clay County Fire Rescue (CCFR), Clay County Sheriff's Office (CCSO) and Emergency Communication Centers (ECCs). It was determined by a high-level assessment completed by an independent third party, that Clay County public safety services would benefit from the centralization of operations of the four PSAPs. Centralizing operations means the direct dispatch of all calls for service, as well as consolidation of management and governance.

Essential communication and dispatch across the County for citizens. Improved Public Safety performance and response. The Co-Located Communications Center will provide synergy inside the centers with the correct communications layout. A radio tower will improve the range of communications.

### c. What direct services will be provided to citizens by the appropriation project?

Direct dispatch of all calls rather than routing of calls from 911 to one of the four secondary Public Safety Answering Points resulting in the expedited dispatch of services.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

All of Clay County, Florida (population 218,245)

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

# Reduce transfers of 911 calls – Call transfers are inherent in locations that have both primary and secondary PSAPs. By consolidating CCSO and CCFR, a total of 16,759 call transfers are eliminated, which on average saves 90 seconds of call-handling time per call (~28,436 minutes per year) which translates into reduced processing time for fire and EMS calls for service.

- Eliminate call workflows that inherently include two or more transfers of 911 calls.
- Provide zero-minute response to a majority of fire and EMS calls for service.
- Staffing improvements to provide enhanced coverage for 24 hours a day, 7 days a week (24 x 7) operations.
- Reduce staffing shortages.
- Eliminate facility congestion at CCSO.
- Improve training completion statistics.

### for failing to meet deliverables or performance measures provided for the contract?
