## 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

Based on a "Readiness Assessment", consisting of 1,400 hours of engagement, undertaken by UF's Board of Trustees, replacement of UF's 18-year old legacy computer system, which currently provides critical support for university financial, payroll, human capital management, grants administration, data and reporting, needs to be modernized. The requested funds will provide Year One funding for the First Phase to replace the current legacy system with a consolidated cloud-based platform.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

UF's 18-year-old current legacy computer system supports operations including: finance, payroll, human capital management, grant administration, and data reporting. As UF moves to the next level of education/research universities, there is a need for better information and faster reports. Shifting to a modernized, cloud-based platform is essential for long-term efficiency & consistency of university operations.

#### c. What direct services will be provided to citizens by the appropriation project?

Modernization of business processes, increases consistency across UF; improved access to data/reporting; enhanced, self-service options/analytical capabilities; increased data transparency through dashboards; provision of a sustainable environment reducing maintenance needs; creation of dynamic/interactive reports for policymakers; more efficient use of staff time; better resource stewardship.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Faculty, staff, students at UF and policymakers. Unlimited numbers of individuals will benefit from the services listed above.

Benefit/Outcome: As UF and UF Health grow in complexity and the data under our care increases in both depth and scope, the current decentralized approach to data management will restrict progress. This requires greater business efficiencies; enhanced/more timely reporting; optimized /improved decision-making; increased transparency; and decreased maintenance costs. Outcome Measure: 1) Data provided from the "Needs Assessment"-compare baseline data to post implementation data. 2) Monitor the Workday contract; 3) Monitor the Implementation Partner contract.
