4. Project/Program Description

The Town of Ponce Inlet is requesting funding for a replacement generator and transfer switch to provide standby power for the Town's Public Works facility. The Public Works building is a 4,000 sq. ft. critical facility that houses all Town public works assets and functions as the primary location for all public works employees. The facility is essential to the public safety mission of the Town. The current generator is more than 10 years old, and repairs are becoming more frequent. Additionally, the continued reliability of the unit is in question due to the age of the unit and its location on the barrier island, exposing it to salt air and extreme weather conditions. A replacement unit will provide reliable back-up power when needed to assure public works services can be provide the community.
