Currently, a consultant of the North Florida Transportation Planning Organization (Atkins) is conducting a study to continue widening SR200 eastward past the intersection of CR107 and Marsh Lakes Drive. The study also includes intersection operational analysis and recommends improvements to SR200 & CR107.
