For example, GEM was first on the ground for Hurricane Ian since landfall actively responding to affected communities.

GEM is fully equipped to respond immediately to crisis and with partners such as Good360, Amazon, Publix, Goya and many others, we're able to bring aid to most vulnerable population quickly and efficiently. By partnering directly with local community organizations and leaders, we're able to distribute aid much more quickly and efficiently than more traditional disaster relief organizations.

The funds will be used to purchase equipment that will allow GEM to better respond to disaster event or other emergency events. GEM not only provides immediate relief but also tends to the often-overlooked gap period and long-term recovery, rebuilding, and redevelopment of a crisis-hit cities and communities. GEM will measure outcome by number of events GEM responds to, including people served, family necessity kits (boxes with snacks, food, other items) distributed), total aid distributed. Volunteers and skilled workers sourced in communities.
