The Shenandoah community is located in the western portion of the Town, a low-lying area that consistently experiences recurring flooding. The Town's Shenandoah Drainage Study conducted in 2019 evaluated various alternatives to alleviate the issues in this vast neighborhood. The proposed project will fund the construction of a pump station to reduce future flooding in the community. The project will improve drainage capacity, enhance water treatment, reduce water levels preand post-storm, and alleviate flooding issues that prohibit residents from entering and leaving the community during a heavy rainstorm.

The Town received approximately \$2,076,400. The money was used for a combination of expenses such as mortgage foreclosure and rental eviction programs, Emergency Order compliance enforcement, PPE Expenses, Cleaning/Disinfection, Public Information, Public Safety Payroll, Facilitate Compliance, Residential Assistance, Small Business Assistance, and Community Programming. The Town also received \$17 million in American Rescue Plan Act funds.
