14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds requested for creating an affordable housing land use master planning, development, and visioning plan serve a specific purpose: to accelerate the vital development of affordable housing within the Pine Hills Clarcona-Ocoee community. This plan has a twofold objective: first, to thoroughly assess housing needs, and second, to formulate a comprehensive strategy that not only meets but also expedites the pressing demand for affordable housing construction in the area.

b. What activities and services will be provided to meet the intended purpose of these funds?

The workforce housing design and build appropriations will fund activities such as design and construction of affordable / workforce housing, infrastructure development, and community amenities. These services aim to create a sustainable living environment for local workers, fulfilling the fund's intended purpose.

c. What direct services will be provided to citizens by the appropriation project?

The appropriation project will provide citizens with direct services including the construction of affordable housing units, infrastructure improvements, community facilities, and supportive services like counseling and financial literacy programs that will be attracted based on a successful design & build plan that seeks public and private participation.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for this project is local workers seeking affordable housing. It's expected to serve approximately 500 individuals, offering them cost-effective living options close to their workplaces in compliance with the Florida Legislative CS/SB 102 LIVE LOCAL ACT.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The funding for the affordable workforce housing on 65 acres aims to create accessible, cost-effective homes for local workers, improving living standards, and reducing commute times. Outcomes will be measured by the number of housing units built, occupancy rates, resident commute time reductions, and satisfaction surveys, alongside economic impacts like job creation and local business growth.
