- 2. Enrich cultural experience socializing with students from different cultures, teaching healthy honest competing skills and promoting enhance self- esteem in competition and socializing, meet and greet, teacher and coach one-on-one and encouragement training, and getting out into the community, noting that boarding one's education can offer greater opportunities in self, group, and social development.
- 3. Improve quality of education- Providing scholarships for high education this helps and benefits families with low income and our at risk students with some of the expenses of college tuition.
