The funds requested will be utilized for the construction of a Mental, Physical, and Emotional Health Center (MPEHC), as well as the acquisition of the necessary equipment for all of the mental, physical, and emotional health wellness needs of the Pasco Sheriff's Office. As a result of the rapid increase in population and calls for service in Pasco County, the need for a centralized location to house these resources has become clear. With this center, we can take major steps to protect the continued health and wellbeing of all of our members.

b. What activities and services will be provided to meet the intended purpose of these funds?

With these funds, the Pasco Sheriff's Office will be able to fully provide the mental, physical, and emotional health and wellness needs for all of our deputies. These activities and services would include physical conditioning equipment and services, space for mental health services and peer support related activities, information technology to assist with the objectives of the center, and other related equipment and services.

c. What direct services will be provided to citizens by the appropriation project?

As mentioned above, it is critical that we prioritize the mental, physical, and emotional health of our deputies to ensure their wellbeing in all aspects as they respond to calls for service for our citizens. Responding to the variety of calls for service that a law enforcement agency receives, some highly stressful or traumatic, can take a toll on the wellbeing of our deputies or lead to further trauma and health concerns if left unaddressed. By prioritizing the wellness of our deputies in this way, we can take major steps to ensure that our response to all calls for service continue to remain effective, efficient, and appropriate for all of the citizens of Pasco County.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project would be both the law enforcement officers of the Pasco Sheriff's Office as well as the citizenry of Pasco County as a whole. As a result of this funding, the Pasco Sheriff's Office will be able to better ensure the continued health and wellbeing of its deputies, which would in turn result in increased efficiencies, effectiveness, and quality of response for the citizenry of Pasco County during calls for service.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

As a result of the funds requested for this project, the expectation is that Pasco residents would benefit from the continued focus and care provided for the mental, physical, and emotional wellbeing of the law enforcement officers of the Pasco Sheriff's Office. Regardless of the situation, Florida law enforcement officers must be ready and willing to defend the life, liberty, and property of the citizens of the State of Florida. Therefore, it is incumbent upon law enforcement agencies, to ensure that each and everyone one of our law enforcement officers remain ready willing and able. This can be measured through general increases to mental, physical, and emotional health preparedness among deputies.
