Funds will be used to build The Center for Children and Families. The Center will provide co-location of child welfare programs to include YFA case management services, Florida Department of Children and Families (DCF) Child Protective Services, Diversion providers, and other non-profit agencies to increase communication and service coordination to streamline access to services, reduce permanency delays, and provision of services to protect children and strengthen families.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Center will house and co-locate the full continuum of Child Welfare Programs in Pasco County. Co-location and collaboration between providers will result in earlier family engagement, service referral and deployment intended to provide child safety and family strengthening. Co-location will also reduce current expenditures on leases by DCF, Community Based Care lead agencies, YFA, Diversion providers and those funds can be reinvested in services for children and families and the non-profit programs.

c. What direct services will be provided to citizens by the appropriation project?

The full continuum of child welfare programs will be co-located at the Center to include: DCF Child Protective Investigations, YFA case management services, Diversion and other non-profit services to protect and heal children and families and facilitate permanency in a timely manner so families can sustain safely without continued child welfare interventions.

d. Who is the target population served by this project? How many individuals are expected to be served?

The Center will serve children and families involved in the child welfare system in Pasco County. It is anticipated based on current number of families served, that more than 800 children and families will be served annually.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The Center will house and co-locate the full continuum of Child Welfare Programs in Pasco County. Co-location and collaboration between providers will result in earlier family engagement, service referral and deployment intended to provide child safety and family strengthening. Co-location will also reduce current expenditures on leases by DCF, Community Based Care lead agencies, YFA, Diversion providers and those funds can be reinvested in services for children and families and the non-profit programs. The methodology will be the percentage of families diverted from the dependency system at the time of service delivery and within 6 months of case closure. Also, the percentage of children in the dependency system who achieve permanency within 12 months of removal.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Failure to meet the deliverables or performance measures would result in a reduction of approved appropriations.
